AMENDMENT TO BYLAWS OF  
 SOUTHAMPTON POINTE PROPERTY  
 OWNERS ASSOCIATION, INC.

THIS AMENDMENT to the Bylaws of Southampton Pointe Property Owners Association, Inc. ("Association") made and entered into as of the 12th day of November, 2010.

**WITNESSETH:**

WHEREAS, the Master Deed of Southampton Pointe Horizontal Property Regime ("Master Deed") was recorded in the RMC Office for Charleston County, South Carolina on the 29th day of September, 2005, in Book V-555, at Page 464; and

WHEREAS, the Bylaws of the Association ("Bylaws") are attached as Exhibit "E" of the Master Deed; and

WHEREAS, at a Special Meeting of the Association held November 12, 2010, Members of the Association holding at least two-thirds (2/3) of the total votes in the Association voted to amend Article 3, Section 3.1 of the Bylaws so as to require that all Board members reside full-time on the Property.

NOW, THEREFORE, Article 3, Section 3.1 of the Bylaws is amended as follows:

Delete that portion of the second sentence which reads "Except with respect to directors appointed by the Developer, the directors shall be Owners;" and

Substitute the following language: "The directors shall be Owners and shall reside full-time on the Property;"

EXCEPT AS AMENDED HEREIN, all other terms and conditions of the Bylaws shall remain in full force and effect.
